The quote should be submitted on or before **11th February 2016.** The quote should be superscribed as **QUOTATION FOR SUPPLY OF PRINTER CARTRIDGES,** on the envelope, failing which the offer/quote may not be considered and may remain unopened, or be opened with some other quotation or may be accidentally opened before due date rendering it to be treated invalid as per the discretion of IMU.

3. The quotation must be in the enclosed prescribed proforma on the letter head of the firm duly signed by the Proprietor/Partner/Director or their authorized representative, in case of signing of quotation by the authorized representative, letter of authorization must be attached with the quotation. Rates must be quoted as per the format specified at **Annexure I.** If there is no explicit mention of taxes and other charges, if any, in the offer/quote, the price will be deemed as all inclusive including taxes. The quoted price shall be valid for at least three months from the date of closing of the quotation. The items should be delivered within 2 weeks of the date of the purchase order. If the supplier fails to deliver the material on or before the stipulated date, then a penalty at the rate of 0.5% per week of the total order value shall be levied subject to maximum of 10% of the total order value. Payment will be only after satisfactory delivery / commissioning of material.
